Junior Mate Program Blanket Permission Form**

I understand that my child, if selected as a Second Level Junior Mate, must be drug-tested at my expense through a BHCFA Member's drug test program on an initial basis prior to being allowed aboard that Member's boat for training. I will advance all costs to any BHCFA Member to whom my child is assigned for training for drug-test programs and test expenses. I understand that my child will be assigned to at least two boats per season for training.
